COLLEGE SCHOLARSHIP PROGRAM**

To ensure that your application is reviewed and processed as quickly and accurately as possible, please read and follow these procedures and requirements as written.

PROCEDURES

The Staff member applying for a scholarship must:

- Complete the application personally. Applications must be legible and submitted in ink.
- **Enclose only the items requested** in the requirements (no biographies, resumes, or supplementary lists of activities).
- **Answer all questions on the application.** ("See attached" is not an acceptable answer.)
- Submit all applications to the Camp Director by September 1st. Mail to: Camp Director, Buffalo Trail Scout Ranch, 1101 W. Texas Ave, Midland, TX 79701.
- Be advised that applications become the property of the Buffalo Trail Council and will not be returned to the applicant.
- Scholarships are earned based on summers of service to Buffalo Trail Scout Ranch. Each summer of service is worth \$250, with the maximum scholarship being \$2,500 (10 years of service). Once a staff member has worked 10 years, they may only receive a maximum of \$2,500 per subsequent summer.
- A maximum of \$2,500 may be used during any academic year. Scholarships do not rollover from school year to school year.
- Scholarships are earned only for those complete summers of employment.
- Termination of employment at any time during the summer will nullify scholarships.
- Scholarships may be used for tuition and fees, housing, books, etc. All checks will be made payable to the institution.
- Scholarships accrue from year to year as long as the camp staff member remains in employment as a member of the camp staff at BTSR. When a staff member ceases employment, all previously accrued credits are null, and the scholarship award ceases. (Ex: A staff member works only the summer of their 10th and 11th grade years of high school would not qualify to utilize any scholarship funds.)
- A former camp staff member who returns to the BTSR staff after a hiatus of a summer or more will get credit for their previous summers of employment only, but not the years they were absent.
- Policies and guidelines are subject to change annually as the program is reviewed and updated.

REQUIREMENTS

All applicants must:

- Be a current member of the BTSR summer camp staff and registered with the Buffalo Trail Council, BSA as a member of Venturing Crew 1947.
- Be in good standing as a member of the staff and not under any probationary or disciplinary procedures from camp management. Termination of employment or disciplinary procedures voids any potential scholarships.
- Have graduated high school and currently be enrolled (or enrolling in the fall) at a college or university and enrolled as a full time or part time student working towards an undergraduate degree.
- Have demonstrated leadership ability as a member of the BTSR camp staff and Scouting in general, as well as a strong record of participation in a variety of activities outside of Scouting as well.
- **Proof of enrollment must be attached to this application before ANY funds will be dispersed. ½ of the funds will be dispersed for the fall semester and the other ½ in the spring. Before spring funds are dispersed, proof of enrollment for that semester must be provided as well. If taking a semester off, or if graduation occurs mid-year, no funds will be dispersed for that semester.**
